1.0 BEST PRACTICE GUIDE

1.1 SI advised that one error had appeared in the latest edition, the publishers had changed Traffic Management to "Active Traffic Management" which is now a redundant term. A recommendation was put forward that revised procedures for Managed Motorways now known as Smart Motorways are added as an Addendum and sent to all operators. If the HA want a full revision of the whole document they will need to provide the funding.

2.0 SMART MOTWAYS (All Lane Running)

2.1 SI recommended that the Executive Steering group decide on all service operating procedures, the first part of the scheme is due to go live on the M25 Jct 23-25 from February 2014.

- Live Lane Breakdowns (Light and Heavy)
- Lights in ERA's

• Appropriate lane closure for HGV attendance

Once agreed the document needs to be sent to all garages, senior and regional managers, technicians, IVR, ACPO, AVRO, RRRA, RHA and put on the website

3.0 TRL TRIAL – VEHICLE LIGHTING

3.1 MP showed some statistics and video of the recent trial that TRL carried out for the HA. A recommendation was agreed by the group to review the advice on where the customer should stand at the initial breakdown and when the technician arrives.

Small group (SR/CW/RD/MP) to carry out the above review plus review the advice given at point of call, review the advice that the technician gives on arrival and review the fend policy to see if it can be improved.

4.1 SI to present the recommendation to the Executive that Breakdown and Recovery operators should be authorised to use red flashing lights but only on fast dual carriageways if the breakdown is in lane one and they are stationary.
